### Beginning of Aerial Photography

 First aerial photography involved the use of balloons, kites & pigeons (19<sup>th</sup> century).

■ 1909 Wilbur Wright uses a camera on a plane.

In World War I the use of aerial photography became routine & common place. Over 20,000 photos printed daily by the end of war.

### Aerial Photography & Assessment

In the 1920's Connecticut was the pioneer in the use of aerial photography for tax equalization.

Municipal Service Company of New Britain in conjunction with Fairchild Aerial Survey performed these services.

#### **Costs & Timing – 1920's**

Middletown

(42 square miles)

Cost - \$4,000

Timing – 60 Days

2016 Adjusted Cost - \$56,967 (or \$1,347/Square Mile)

### Costs & Timing – 1920's (cont.)

New Britain

(13 square miles)

Cost - \$48,000

Timing – Four Years

2016 Adjusted Cost - \$683,602

(or \$52,585/Square Mile)

## Municipal Benefits due to Aerial Surveys in 1920's

- Middletown new school & fire-house with long-term debt pre-payment.
- Manchester new town hall.
- East Haven new school.
- Berlin larger road appropriations.

## Municipal Benefits due to Aerial Surveys in 1920's (cont.)

"It may be readily seen for the foregoing that in each case the city of town was soundly financed, its bonding capacity increased, the grand list raised, the tax rate lowered and this accomplished in spite of an increased budget."

#### Conclusions from the 1920's

"We have just complete a reappraisal of all property located in our city, which covers an area of 42 square miles. Many miles of this is woodland and hilly, making it very inaccessible for land surveyors. The aerial maps were a great help in locating boundaries and classifying lands, showing cultivated, wooded, swamp, etc. A great savings was effected in time and money by using these aerial maps"

#### Conclusions from the 1920's (cont.)

"It may be safely stated that any municipality which couples the aerial survey with a just tax reappraisal will be able to recoup all costs and salaries incidental to the work within two years as a maximum, in addition to finding that is more soundly and honestly finances heretofore."
