GO OVER Q-BRIDGE AND GET OFF EXIT 50 (WOODWARD AVE.).

GO TO 3RD (THIRD) TRAFFIC LIGHT AND TAKE A RIGHT ONTO TOWNSEND AVENUE.

FOLLOW DOWN 2.5 MILES TO LIGHTHOUSE ROAD.

TAKE RIGHT.
